Frac w/ 5447 bbls slick water; 59400 lbs 30/70 Brown Sand; 239100 lbs 20/40 White Sand; 9700 lbs 12/20 Super IC.

Perforate from 6050' to 6650', 36 holes.

Frac w/ 5363 bbls slick water; 58500 lbs 30/70 Brown Sand; 241500 lbs 20/40 White Sand; 8800 lbs 12/20 Super IC.

8/12/06 Perforate from 5150' to 5750', 36 holes.

Frac w/ 4655 bbls slick water; 52100 lbs 30/70 Brown Sand; 152300 lbs 20/40 White Sand; 8000 lbs 12/20 Super IC.

Flow back to clean up.
