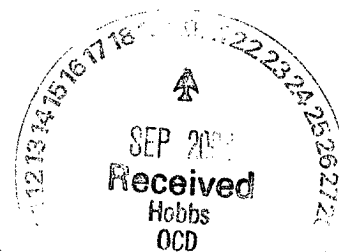

Drill 9-7/8" hole to 450'. TD 9-7/8" hole at 1600 hrs 8/4/2006. Run 10 jts, 7", 20#, J55, ST&C csg. Set at 449'. Cmt w/350 sx class "C" + 2% CaCL2. Yld - 1.34, Wt. 14.8#. Plug down at 2200 hrs, 8/4/2006. Circ 13 sx to surface.

Notified OCD Hobbs, NM of running csg & cementing.

WOC, NU and test BOP & manifold to 3000 psi - OK.

Drill out w/6-1/8" bit to 450'.
