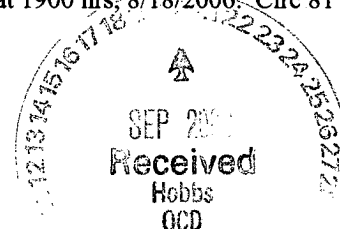

Cmt csg w/225 sx BJ Lite (Yld – 2.3 cu ft, Wt – 12.0 #/gal) + 225 sx Class "C" + .6% FL62 + .2% SMS (Yld – 1.33 cu ft, Wt. 14.8#/gal). Plug down at 1900 hrs, 8/18/2006. Circ 81 sx to the surface. Rig released at 0200 hrs, 8/19/2006.
