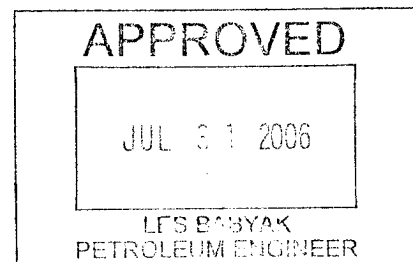

1. Set CIBP @ 15430'. Cap w/ 50' cmt.
2. Perf Atoka Bank 14,372-78, 14,400-08, & 14,424-33 w/ 2 spf.
3. Acdz w/ 2500 gals 15% acid.
4. Swab test to evaluate. If unsuccessful continue to Step 5.
5. Set CIBP @ 14,350'. Cap w/ 50' cmt.
6. Perf Bone Springs 12,251-64 w/ 2 spf.
7. Acdz w/ 1000 gals 7-1/2% acid.
8. Swab test to evaluate.
9. Frac as directed.
10. Return well to production.
