


Echo Production, Inc. hereby requests permission to omit the required 13 3/8" casing string. The Stiletto 21 Federal Com. #1 - offsetting to the north and the Stiletto 27 Federal #1 - offsetting to the south were both drilled without loss of drilling fluid or cement in the 13 3/8" and 8 5/8" sections.

The Mewborne Pine Box '21' Federal #1 omitted the 13 3/8" string and they were able to drill the 8 5/8" section and set casing without loss of drilling fluids.

Conductor is large enough to add the larger string of casing if problems are encountered while drilling 8 5/8" section.
