The referenced well was TA'd on 7/14/05 and inadvertently witnessed by the OCD. The subsequent report, test and chart was also inadvertently submitted to the OCD. That test and chart along with the OCD approved sundry is attached.

This well is in our West Red Lake Unit waterflood. The well therefore has utility should additional intervals in the San Andres be perforated and flooded.

As the WRLU is expected to produce for quite some time, the potential usefulness of this well will also be ongoing. As this situation is not expected to change, we are requesting a longer term temporary abandonment.
