Yates Petroleum Corporation respectfully requests permission to change the hole and casing sizes for this well as follows:

12 1/4" intermediate hole with 9 5/8" casing set at 3450' and cemented to surface.
8 3/4" production hole with 5 1/2" casing set at 9400' and cement tied back 500' into 9 5/8" casing.
If hole conditions dictate, 7" casing will be set and cement will tie back 500' into 9 5/8" casing, then a 6 1/8" hole will be drilled to TD and 4 1/2" casing will be set and cement will tie back 500' into 7" casing.

Surface hole and casing size will remain the same.
