13. Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Yates Petroleum Corportation plans to drill an 8 3/4" vertical pilot hole to 5,400' then plug back and kick off at approx. 4,720' with an 8 3/4" hole to approximately 5,225' (MD). At this point it will be determined if hole conditions warrant setting 7" casing. If 7" casing is set, then top of cement for the 7" casing will be brought back up to 500' above the base of salt. A 6 1/8" hole will then be drilled to TD where 4 1/2" casing will be set and cement brought up 500' into 7" casing. If 7" casing is not set, then the hole size will be reduced to 7 7/8" and drilled to TD where 5 1/2" casing will be set and top of cement will be brought up to 500' above the base of salt.
