Drill 9-7/8" hole to 1250'. TD 9-7/8" hole at 1400 hrs 9/14/2006. Run 31 jts, 7", 26#, J55, ST&C csg. Set at 1250'. Cmt w/425 sx BJ Lite 65:35:6 + 5% salt + 1/4#/sx celloflake. Yld – 1.98, Wt. 12.8. Tail with 200 sx Class "C" + 2% CaCL2. Yld – 1.34, Wt. 14.8#. Plug down at 0800 hrs, 9/15/2006. Circ 62 sx to surface.

Notified OCD Hobbs, NM of running csg & cementing.

WOC, NU and test BOP's to 2000 psi – OK.

Drill out w/6-1/8" bit to 1250'.
