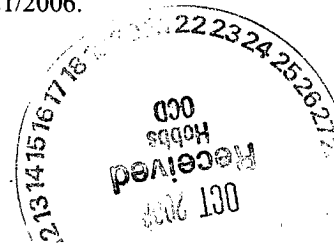

Cement 4.5" csg w/ 250 sx BJ Lite 50:50:10 + 5% Salt, Yield 2.3 cu ft at 12.0 #/gal. Tail w/ 225 sx Class "C" + .5% FL-62. Plug down at 0200 hrs, 9/21/2006. Circulated 158 sx to surface. Rig released at 0600 hrs, 9/21/2006.
