Intermediate casing will be set at 4300', cement circulated to surface. If commercial, production casing will be ran and cemented, perforated, and stimulated as need to gain production. **MUD PROGRAM:** 0-400' FW Gel; 400'-1980' FW; 1980'-4300' Red Bed Mud/Oil; 4300'-7650' Cut Brine; 7650'-11630' SGel/Oil; 11630'-TD SGel/Starch/4-6% KCL. No H2S is anticipated. **BOPE PROGRAM:** A 5000# BOPE will be installed on the 9.625" casing and tested daily for operational.

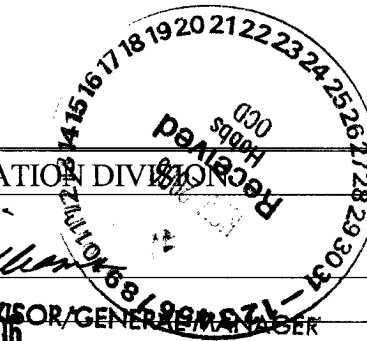
