- RUPU & RU. Test casing to 800 PSI. Unset packer & POOH w/tbg & pkr. RUPU 10/03/06 RDPU 11/02/06
 - RIH w/5" casing scraper to 3932'.
 - RIH w/CIBP for 5" casing set @3932'.
 - RIH w/RBP set @2093'. Load & test casing & plug to 500 PSI/held OK. Dump 1 sx of sand on plug. RDPU. TA well.
 - MIRUPU & RU.
 - Wash sand off of RBP. Release and POOH w/tbg & RBP.
 - RIH w/bit & drill collars to 3900'
 - Drill out CIBP @3932' & push to bottom @4220'. Circ clean.
 - RIH with 5" Uni-6 pkr w/1.875 "F" nipple on 129 jts of 2-7/8" Duoline 20 tbg. Set pkr @4042'.
 - Test casing to 600 PSI for 30 minutes and chart for NMOCD.
 - RDPU & RU. Clean location. With completion of this work, CO2 gas injection will commence under Division Order R-6199-B.

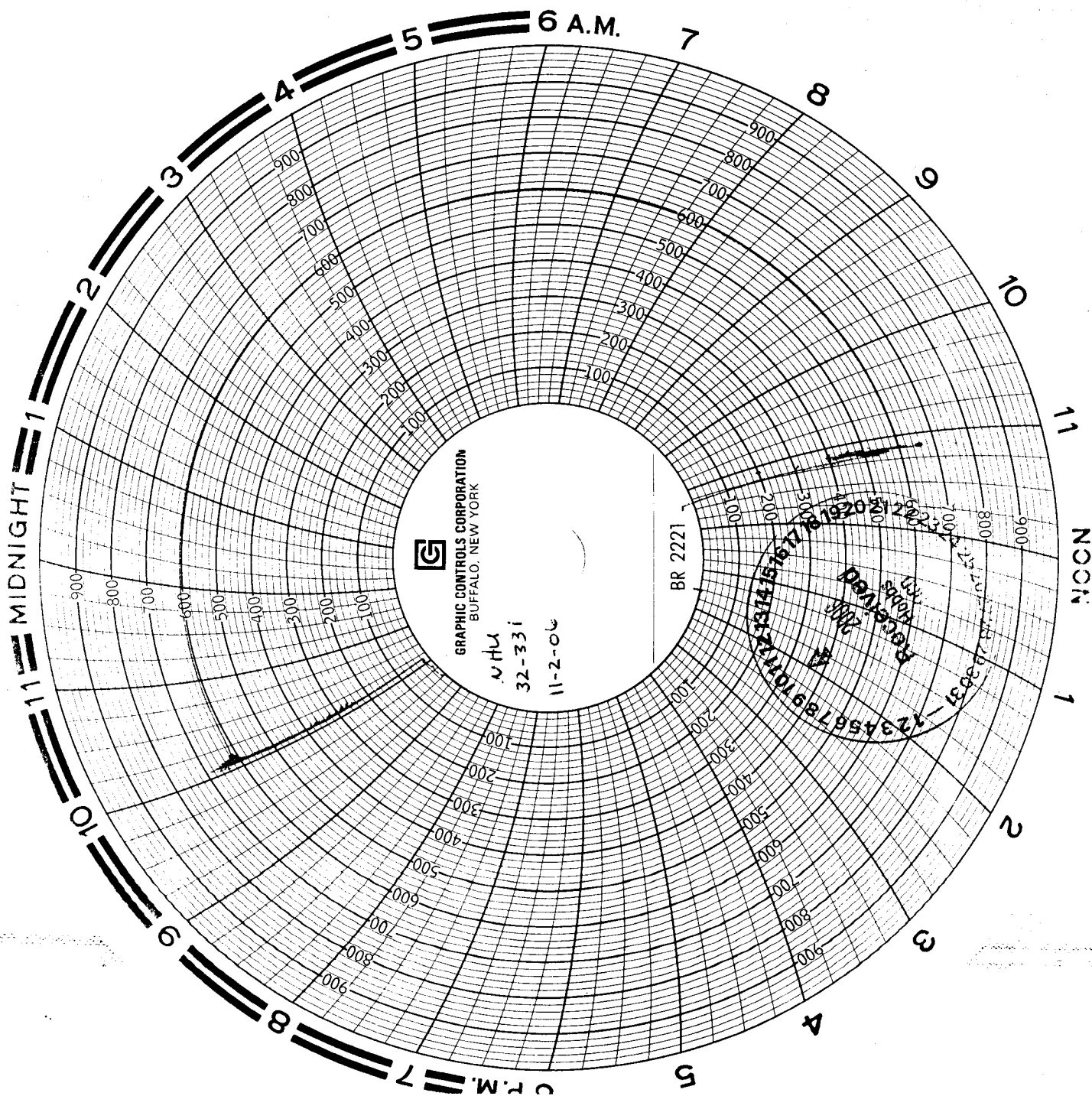
