Sight Security Diagram

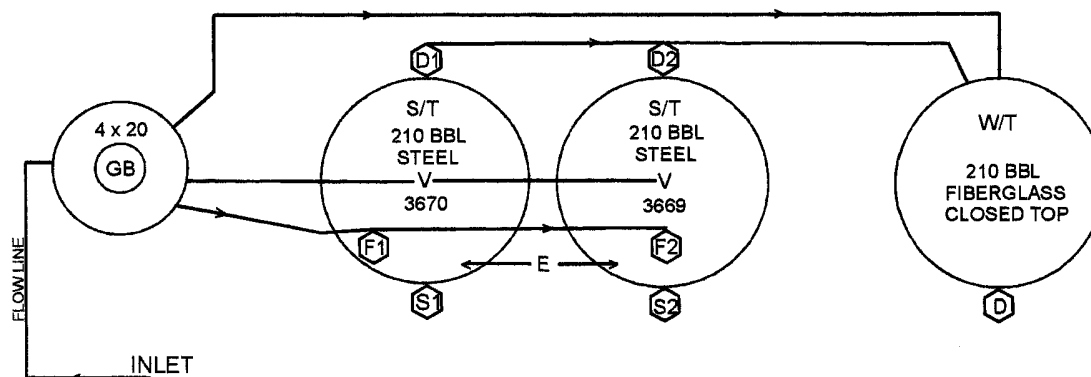

Production phase. All drain valves, D1 & D2, and all sales valves, S1 & S2, sealed & closed.

Sales phase. The tank from which sales are being made will be isolated by sealing closed the drain valve, fill valve and the equalizer valve during sales.

Draining phase. The tank being drained will be isolated by sealing closed the sales valve, fill valve, equalizer valve and the drain valves on the other tanks.

Drain valve on water tank not sealed.
