A CIBP was set at 8285' on January 6, 2002; 35' cmt was dumped on top of plug.

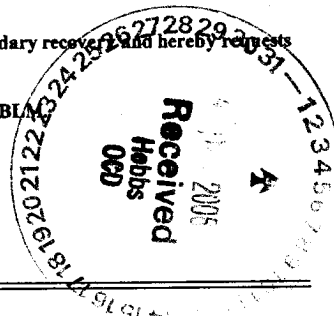
A Sundry Notice requesting a change of operator was filed with the BLM on February 16, 2005 and approved by Linda A. Askwig on March 7, 2005 (a copy of which is enclosed).

The subject well is in an area of Queen Sand production. Seely Oil Company is evaluating the area for secondary recovery and hereby requests permission to temporarily abandon the well until the evaluation is complete.

A casing integrity test was performed (chart enclosed). The test was witnessed by Mr. Marlon Deaton of the BLM.

After 8/17/07 the well must be online or plans to P & A must be submitted.

Well has been in TR or OSE since 1998.
