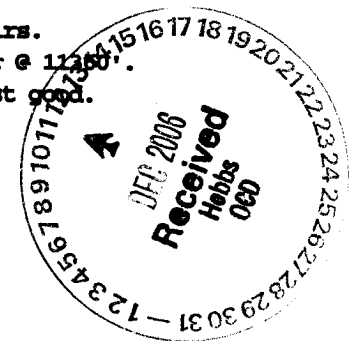

Pressure test 2 7/8" X 5 1/2" annulus to 500 psi for 30 min. Test good.
Rig down & move off.**

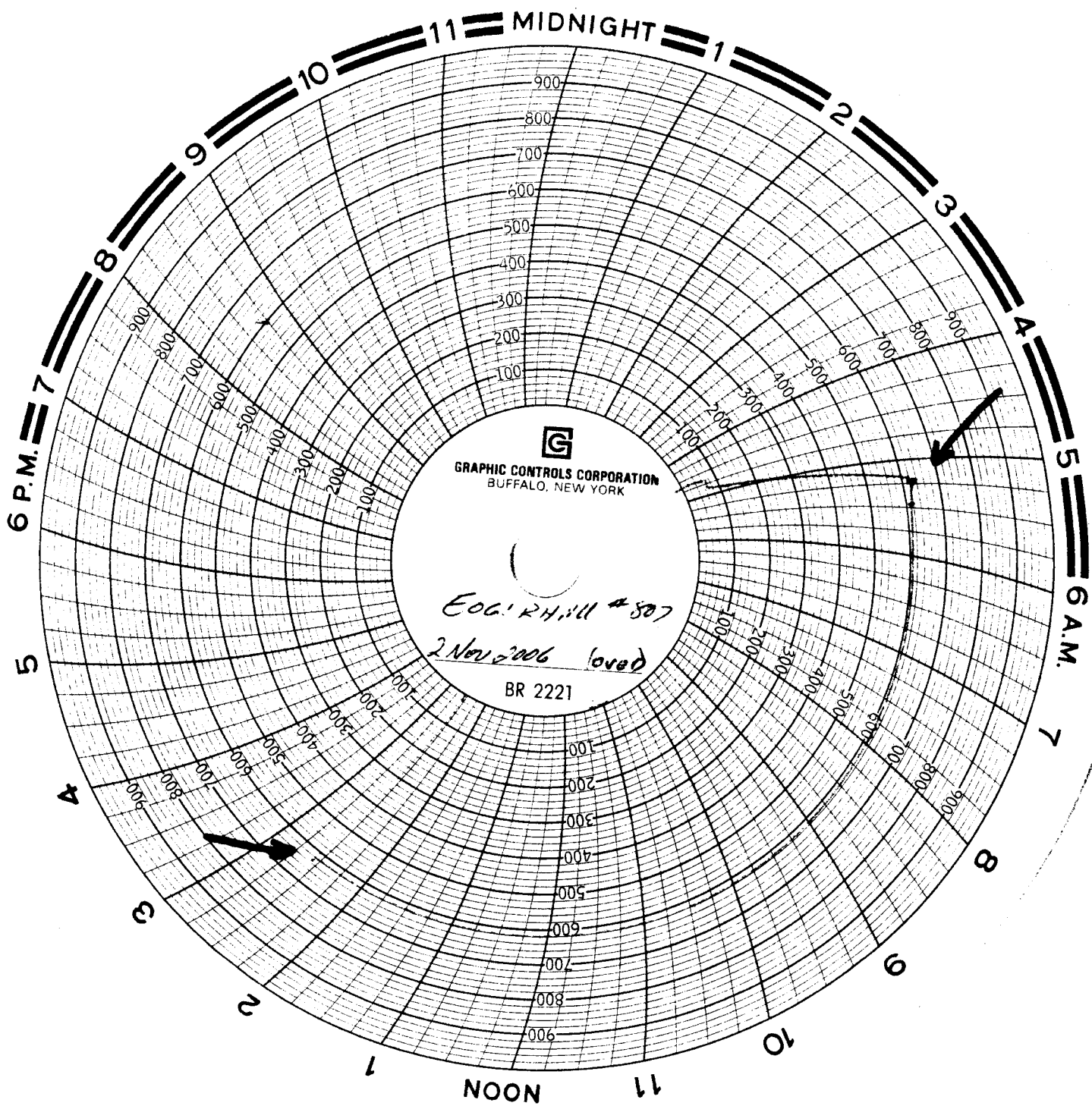
