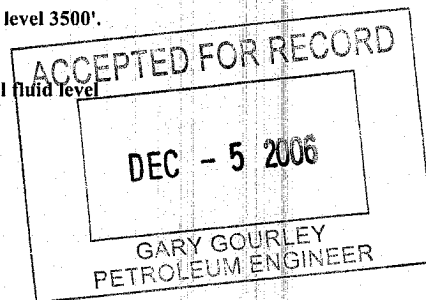
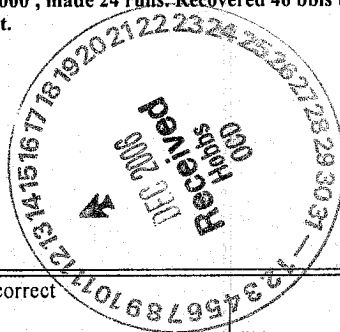

11-30-06 Open up well, start swab. TOF 3000', made 24 runs. Recovered 46 bbls total fluid. Final fluid level at 3800'. Rig down and move out.
