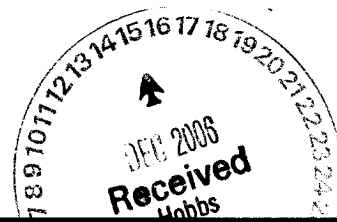

Cement 4.5" csg w/ 175 sx 50:50 Poz Class C + 10% gel sodium chloride. Tail w/ 200 sx Class "C" + .6% FL-62 + 2.2% sodium chloride. Plug down at 1630 hrs, 11/18/2006. Circulated 36 sx to surface. Run logs. Rig released at 0200 hrs, 11/19/2006.
