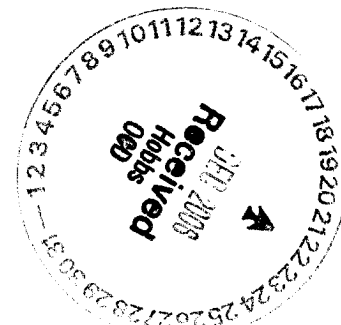

Legacy Reserves Operating LP requests authority to flare gas during work procedure to reactive subject well. According to BLM NTL 4-A Section III.C, an operator shall vent or flare gas not exceeding a period of 30 days or the production of 50 MMcf of gas. Legacy Reserves estimates a short-term flare of 60-80 Mcf/d for 30-60 days. Production test will utilize a portable separator/well tester and portable test tank.
