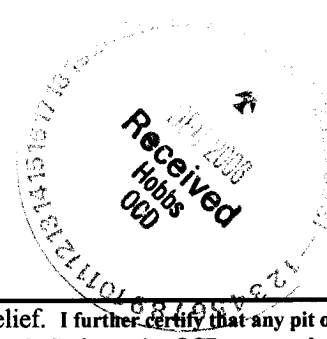

Yld - 1.98, Wt. 12.6#. Tail w/200 sks Class "C" + 2% CaCl2. + 1/4# Cello Flake. Yld - 1.34, Wt. 14.8#. Plug down at 1000 hrs, 12/11/2006. Circ 130 sx to surface.

Notified OCD Hobbs, NM of running csg & cementing.

WOC, NU and test BOP & manifold to 1500 psi - OK.

Drill out w/6-1/8" bit to 1212'.
