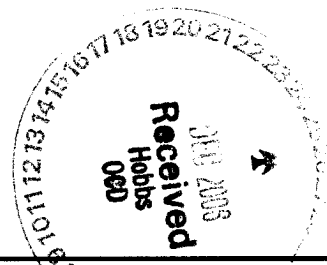

Cement 4.5" csg w/ 175 sx 50:50 Poz Class C + 10% gel + 5% sodium chloride. Yld – 2.3, Wt. 12.0#. Tail w/ 200 sx Class "C" + .6% FL-62 +.2% sodium metasilicate. Yld – 1.33, Wt. 14.8#. Plug down at 1315 hrs, 12/5/2006. Circulated 84 sx to surface. Rig released at 1900 hrs, 12/5/2006.
