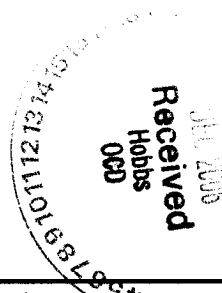

Drill 9-7/8" hole to 1244'. TD 9-7/8" hole at 1230 hrs 11/29/2006. Run 30 jts, 7", 20#, J55, ST&C csg. Set at 1244'. Cmt w/450 sx class "C" (35:65:6) + 5% salt + 1/4# Cello Flake. Yld – 1.98, Wt. 12.6#. Tail w/200 sks Class "C" + 2% CaCl2. + 1/4# Cello Flake. Yld – 1.34, Wt. 14.8#. Plug down at 2300 hrs, 11/30/2006. Circ 230 sx to surface.

Notified OCD Hobbs, NM of running csg & cementing.

WOC, NU and test BOP & manifold to 1000 psi – OK.

Drill out w/6-1/8" bit to 1244'.
