

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. - (1) Move in and rig up unit.
- (2) Release packer and pull 3 joints tubing. Reset packer @ 8745'.
- (3) Rig up Halliburton & cement squeeze Abo perfs from 8910-20' with 250 sacks cement to 1500#.
- (4) Pull out of hole with tubing and packer.
- (5) Pick up 6 - 4 1/4" drill collars with 4 3/4" bit, six collars and trip in hole on tubing.
- (6) Drill out cement. Test squeeze to 1500#.
- (7) Continue in hole and drill bridge plug @ 9040'. Pull out of hole with bit & collars.
- (8) Pick up overshot, jars, bumper sub, drill collars and trip in hole.
- (9) Latch on to fish - 1 joint 2 3/8" tubing and tubing anchor. Knock loose and pull out of hole.
- (10) Clean out to PBTB @ 9758'.
- (11) Run production equipment, tubing and rods. Put on pump. Pump Bough "C" perfs - 9278-34'.
