09/28/06 Cemented casing with lead of 260 sx Premium Plus (wt 13.7, yld 1.68) + 4% Bentonite + 2% CaCl + 0.125# Poly-e-flake and tail of 150 sx Premium Plus (wt 14.8, yld 1.34) + 0.125# Poly-e-flake + 2% CaCl. Circulated 116 sx to surface.

09/29/06 Pressure tested casing to 1000 psi for 30 minutes. WOC 26 hours.

10/03/06 Reached TD of 12-1/4" hole (3500'). Ran 9-5/8" 40# K-55 LTC to 3500'. Cemented with lead of 1245 sx Interfill C SBM (wt 11.9, yld 2.45) + 0.125# Poly-e-flake and tail of 200 sx Premium Plus (wt 14.8, yld 1.33) + 1% CaCl. Circulated 183 sx to surface.

10/05/06 Pressure tested casing to 1000 psi for 30 minutes. WOC 32.5 hours.
