11/27/06: Drill to TD at 4477'. RU casing crew and run 115 jts. 5-1/2", 15.5#, J-55, LT&C casing with 12 centralizers and set at 4477'. RU Halliburton and cement first stage with 250 sx. Premium Plus. Plug down, drop bomb, open DV tool and circulate 100 sx. to surface. Circulate 4 hours between stages. Cement second stage with 600 sx. Interfill 'C' (lead) and 100 sx. Premium Plus (tail). Circulate 57 sx. to surface off second stage. ND BOP and set casing slips. Cut off casing and install wellhead. Jet and clean pits and RD.

Release drilling rig at 12:00 p.m., 11/27/06.
