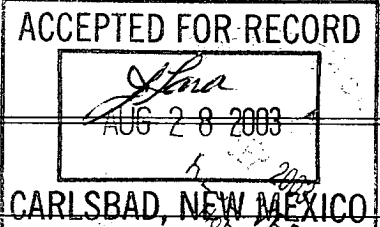

Safety Meeting (MIRU-Remove Head-Pull Rods-NDWH-NUBOP Pull Tubing)

MIRU. Rig up Tessco remove head. Unseat pump. Lay down 55 7/8" C-Rods 108 3/4" C-Rods 2-1.5" K-bars 1-2.5" x 1.5"x20' pump. NDWH-NUBOP Test BOP to 2500 PSI test OK. Pooh with 133 Jts. 2 7/8" tubing. Rig up Baker RIH with garge ring to 3680' POOH. RIH with 7" CIBP set @ 3636' POOH. RIH spot 35' cement top of cement @ 3600' shut down.

Safety Meeting (lay down pipe - circ packer fluid - rig down) RIH to 3600' Circ packer fluid. POOH lay down 134 Jts. 2 7/8" send in to ICO. NDBOP - NUWH. Rig Down.

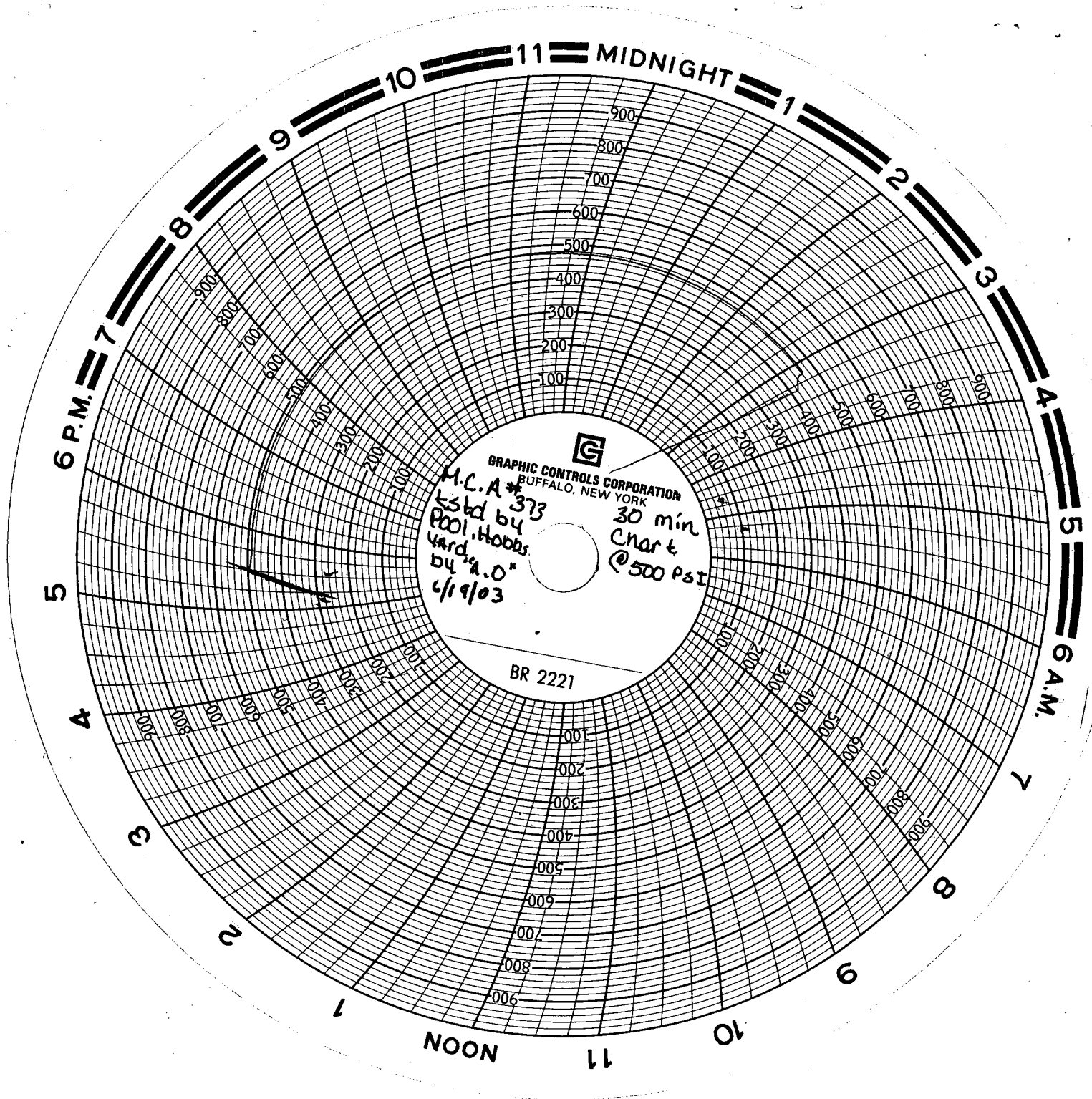
