An accounting error was made in October 2005 and this well was reported as being active with a volume and pressure reported to the State. This was a reporting error and it has been confirmed by field personnel that the well is still in a temporary abandonment status with no production line attached.

On 12/21/06 NMOCD representative Buddy Hill witnessed an MIT at our request to confirm that the well was still TA'd properly. The well passed and the chart is attached. The well currently has an Approval of Temporary Abandonment status that expires 03/28/2010.
