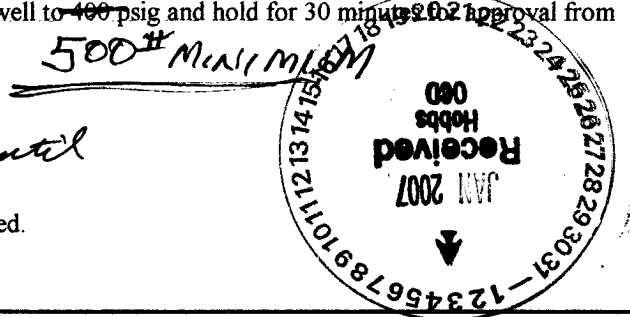

Rig up wire line unit and go in the hole with a gauge ring to 10,505' and come out of the hole with gauge ring and go in the hole with CIBP and set at 10,454' +/- . Come out of the hole with wire line and go in the hole and dump 35' of cement on top of CIBP and come out of the hole with wire line and load hole with 2% KCL and pressure test well to 400 psig and hold for 30 minutes for approval from NMOCD for T/A.
