TIH w/ 2-3/8" tbg. Clean out cmt to 3735'. Run CNL, Delta T, CBL logs. Perforate from 2925'-3590' w/36 holes w/3-1/8" select fire gun loaded with 23 gram charges 1 JSPF (.42" hole size, 30" penetration). Acidize perms w/4008 gals 15% MCA acid dropping 70 ball sealers.

Frac well with 60,680 pounds 20/40 brown sand and 240,720 pounds of 12/20 brown sand with 320 tons 70% CO2 foam carrying 1011 bbls 2% frac fluid. TIH w/111 jts 2-3/8" tbg to 3637'. TIH w/new pump (2" x 1-1/4" x 12') and rods. Turn well over to production.
