Tailed w/750 sacks of 50/50 POZ "H" cmt w/additives w/a yield of 1.31. Both slurries totaled 3808 cubic feet. Circulated 323 sacks of cement to the reserve. Released Big Dog Rig #1 @ 6:00 p.m. 11/28/06.

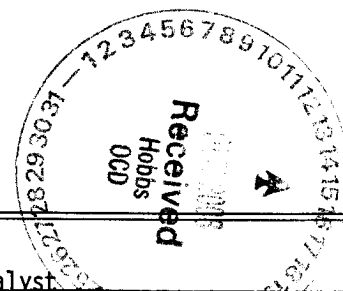
