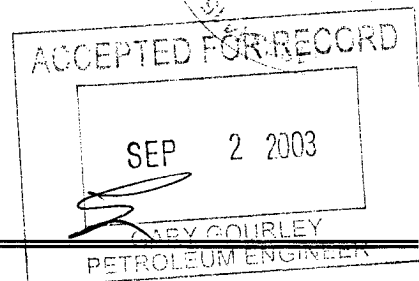

Set CIBP @ 6820' and dump 35' cement on plug. Perforated squeeze holes @ 6660'. Set retainer @ 6598'. Pumped 280 sx Interfill C and 110 sx Super H. Drilled cement and retainer to 6662'. Perforated Delaware 6714-6730' and acidized w/1100 gal 15% NEFE HCL w/75 BS. Set CIBP @ 6650' w/35' cement on top. Perforated Delaware 5694-5716'. Acidized w/1100 gal 15% NEFE HCL w/108 BS.
