Additional Comments: All fluids will be removed from the pit. The burial pit will be constructed adjacent to the drilling pit and lined with a 12 ml liner.
The liner and impacted material will be placed in the burial pit, completely encapsulated and capped with a 20 ml liner, and covered with 3 feet of topsoil to grade.
Any hydrocarbon impacted material will be disposed at an NMOCD approved facility.
Samples will be collected below the liner and results will be submitted with the final C144 form.
Work is scheduled to begin on approximately February 26, 2007.
