11-09-06 Ran 450' 13-3/8" 48# H-40 STC. Cemented with lead of 240 sx Premium Plus Light (wt 12.5, yld 1.97) + 1% CaCl + 1/4# Poly-e-flake and tail of 150 sx Premium Plus (wt 14.8, yld 1.34) + 2% CaCl + 1/4# Poly-e-flake. Circulated 99 sx cement to pit.

11-10-06 Pressure tested 13-3/8" casing to 1000 psi for 30 minutes. WOC total of 34 hours.

11-16-06 Reached TD of 12-1/4" hole (3714'). Ran 3714' 9-5/8" 40# K-55 LTC. Cemented with lead of 1000 sx Interfill C (wt 11.9, yld 2.45) + 1/4# Poly-e-flake and tail of 200 sx Premium Plus (wt 14.8, yld 1.33) + 1% CaCl. Circulated 172 sx to pit.

11-18-06 Pressure tested 9-5/8" casing to 1000 psi for 30 minutes. WOC total of 45 hours.

12-10-06 Reached TD of 8-3/4" hole (10205').

12-12-06 Ran 10205' 5-1/2" 17# P-110 LTC casing. Cemented with 835 sx Permian Basin Super H (wt 13, yld 1.68) + 0.5% Halad-R-344 + 0.4% CFR-3 + 1# Salt + 5# Gilsontite + 0.25# D-AIR 3000 + 0.125# Poly-e-flake + 0.35% HR-7. Released rig. TOC 6359' by temperature survey.
