Drill to 1263'. Set casing at 1263'. Shoe at 1263', FC @ 1219'. Cmt 7", 23# csg w/425 Sx BJ lite (65:35:6) + 5% salt + 12% cellophane. Perf w/200 sx Class C + 2% CACL2. Contacted BLM of running csg and cmt. Drilled to TD 3775'. Run logs. Set 4.5", 11.6# csg @ 3775' w/200 sx BJ lite 50:50 + 5% salt + 200 sx c + .6% FL-62 + 2% SMS. Circ. 27 sx.

Drill out to 3770'. Perf well from 2727-3647' w/49 holes, 1 SPF. Acidize perfs w/4000 gals 15% HCL w/98 ball sealers. Swabbed well. Frac w/60,320# 20/40 sand and 240,200# of 12/20 sand w/325 tons CO2. Clean out fill to 3750' PBTD. RIH w/111 jts 2-3/8" tbg. End of tbg at 3690'. RIH w/rods and pump. Flow to test.
