Pulled rods and tbg. Ran plug and packer, found hole in casing 22' from surface. Cemented hole with 40 sx class C cement. Drilled out cement and tested casing to 500# OK. Could not retrieve bridge plug. Ran overshot and jars without success. Milled out bridge plug, caught with overshot and jars, pulled OOH. Ran 136 jts tbg (4248'), ran 2 x 1.25 x 16' pump on 1 sinker bar, 104-5/8' rods and 62-3/4" rods. Workover commenced 4-4-06, well work completed 5-4-06. Waited on electrical and pumpjack repair.

Returned well to active production service 7-11-2006
