11/17/06 - RIH w/ bull plug, mud anchor, 4' perforated sub, seat nipple, tbg & TAC. ND BOP & NU tree. Run rod string. POOH. Pulled all 7/8 rods & 35 3/4 rods. SD. Leave open to flow line.

11/20/06 - Finish LD steel rod string. RIH w/ rods & pump. Left well pumping. Downhole commingled the Teague Paddock Blinebry and Teague Devonian.
