2/16/07 - MIRU. Bleed down 820# wellbore pressure. TIH w/ remaining 84 jts. 2 3/8" tbg. (134 jts. total) and set CIBP @ 4087'. Perfs f/ 4174' - 4180' covered and TA'd. Pressured 5 1/2" 14# casing to 500# (lost 10# in 15 min). Broke circ and displaced wellbore w/ 110 BFW + 30 gals corrosion inhibitor mixed. TOH LD w/ 134 jts. 2 3/8" tbg., SN, and setting tool. ND 6" 900 BOP, removed 6" 900 x 8 5/8" 8rd adapter flange, and landed 3' x 2 3/8" double collared tbg sub in wellhead. Loaded, pressured wellbore to 540#, and charted 30 min. Cleaned location.
