1/24/07 Torque up rods. and back off. Lay down 70 rods. CWI SDFD.

1/25/07 Rig up wire line. Cut tbg. @ 1813. POH w/ tbg. RIH with 4 1/2 CICR. Could not set. POH. BLM ok'd to spot plug. Spot 25 sx @ 1813. POH SDFN.

1/26/07 Tag plug @ 1534. Circulate hole with mud. Pull up to 1000'. Circulate cmt to surface with 75 sx. Cut off well head. Install Dry Hole Marker. clean Location Rig down.
