Intermediate - 8-5/8" 32# J-55 @ 3810' - cmt to surface
Production 5-1/2" 17# N-80 @ 9200' - TOC @ 5475' by temp survey
CIBP @ 7650' w/ 35' cmt on top in August 2003, csg test witnessed by BLM (Stan Mayo).

P&A procedure: 1. Load hole w/ 9.0 lb/gal mud.

2. Cut off and pull 5-1/2" casing @ 5400', spot 100' Class "C" cmt plug across stub.
3. Tag cement plug.
4. Set 100' Class "C" cmt plug 3860' to 3760'.
5. Set 100' Class "C" cmt plug 569' to 469'.
6. Spot 10' Class "C" cmt plug 13' to 3'.
7. Cut off casing 3' below GL and install dry hole marker.
