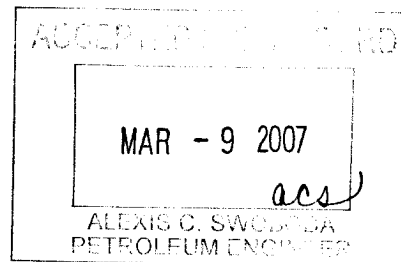
2-22-07: MIRU CU, POH laying down rods and pump.

2-26-07: Perfed 8708-12', 14-30', 39-45' & 8760-65' w/ 3-1/8" csg gun 2 spf. Spotted acid across perfs and set packer @ 8648'.

2-27-07: Acidized w/ 3500 gals 15% NEFE w/ 125 ball sealers. Swabbed well to pit.

2-28-07: Turned well to sales.
