Loaded hole w/ mud, pumped 35sx C cmt w/ 3% CaCl2 @ 2,801'. POOH w/ tubing to 1,170' and WOC. RIH w/ wireline and tagged cmt @ 2,485'. POOH w/ wireline. Loaded hole w/ mud, pumped 25sx C cmt w/ 3% CaCl2 @ 1,170'. POOH w/ tubing to 585' and WOC. RIH w/ wireline and tagged cmt @ 900'. POOH w/ wireline. Loaded hole, and pumped 25sx C cmt @ 585'.
