Called for vacuum truck, WO vacuum truck. Continued in hole w/ workstring, tagged CIBP & cement @ 3,379'. RU cementer and circulated hole w/ 30 bbls mud, pumped 25sx C cmt 3,379 - 3,133'. POOH w/ tubing to 2,806' and pumped 25sx C cmt w/ 3% CaCl2 @ 2,806'. POOH w/ tubing to 1,122' and WOC. RIH w/ wireline and tagged cmt @ 2,600'. POOH w/ wireline. Pumped 25sx C cmt @ 1,122'. POOH w/ tubing, SDFN.
