Move in and rig up Select Well Service Rig #1. Spud 9-7/8" hole at 1700 hrs on 2/17/2007. Notified OCD Hobbs, NM of spud.

Drill 9-7/8" hole to 1265'. TD 9-7/8" hole at 2100 hrs 2/18/2007. Run 31 jts, 7", 20#, J55, ST&C csg. Set at 1265'. Cmt w/400 sx (35:65:6) + 6% gel + 5% salt + 1/4# cello flake. Tail with 200 sx Class "C" + 2% CaCl2. Plug down at 1115 hrs, 2/19/2007. Circ 136 sx to surface. WOC, NU and test BOP's to 1500 # – OK.

TIH and drill 6-1/8" hole from 1265' to 3802'. TD 6-1/8" hole at 0400 hrs 2/24/2007. Run logs. Run 90 jts 4.5" 11.6#, J55 LT&C csg. Set at 3802'. Cement 4.5" csg w/ 175 sx 50:50:10 C:POZ:Gel + 5% Sodium Chloride, Yield 1.4, Wt. 12.6#. Tail w/ 200 sx Class "C" +.6% FL-62 + .2% SMS, Yield 1.34, Wt. 14.8#. Plug down at 2300 hrs, 2/24/2007. Circ. 68 sx. Rig released at 0700 hrs, 2/25/2007.
