2/15/07 Rigged up Ruykendaahl Wireline. Tubing on a vacuum. Casing pressure - 0 psi.

Ran a 2.313" X plug and set the plug in the X nipple below the packer at 11467'. Found fluid level at 2950'. Plumbed line from the casing valve to a frac tank. Loaded the tubing with 17 bbls of 3% KCL water. Pressured up tubing in steps from 2000 psi to 4000 psi. Tubing tested with no communication to the casing. Bled pressure off the tubing and rigged up to pump down the casing. Casing full. Pressured up on the casing with 2000 psi. Held ok.

Rigged up wireline. Ran equalizing prong and broke glass equalizing disc on X plug.

Tubing went on vacuum. Let well equalize. Pulled prong. Ran pulling tool and pulled X plug from X nipple.

Rigged up injection line to tubing. Left line from casing to frac tank to monitor casing side after putting well back on injection.

2/20/07 Ran chart for OCD and returned to injection. Chart attached.
