Circulated 200 sx to surface. Pressure tested casing to 1000 psi for 30 minutes. WOC total of 23.5 hours.

11/22/06 Ran 9-5/8" 40# N-80 STC to 3515.' Cemented with lead of 720 sx Interfill (wt 11.9, yld 2.45) and tail of 200 sx Premium Plus + 1% CaCl (wt 14.8, yld 1.33). Circulated 119 sx to surface. Pressure tested casing to 2000 psi for 30 minutes. WOC total of 36.5 hours.
