10-16-06 MIRU Red Energy Service, ck for fill and ck csg integrity. RIH w/pkr to 30' set, load fresh water, cut and weld on bell nipple. RIH with 2-3/8 notched collar, 14 jts 2-3/8 tbg, bailer, 89 jts 2-3/8. Tag salt ring @ 3530' fell thru and went straight to bottom 3590', no fill. TOOH had oil show on bailer, LD collar and bailer. Prepare to run pkr, secure well and shut down.

10-17-06 RIH w/pkr and 80 jts 2-3/8 tbg, set pkr @ 2,661.75'. Tested csg to 500 psi, held good. POOH with tbg and pkr. RIH w/SN and 107 jts of 2-3/8 tbg set @ 3,571.63'. RIH with pump, 20 7/8 rods, 121 3/4 rods. Pump started sticking, pulled 2 rods out of hole, secure well, shut down. Prep to circ hole down tbg.

10-18-06 RU kill truck to back side and vacuum truck to tbg, load back side with 50 bbls of fresh water, start circulating, circulate clean, space out well, secure well RD.
