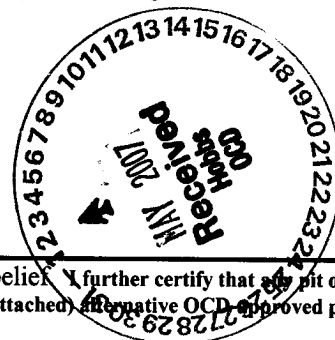

POOH w/pump and rods. Set BP at 3320'. Test to 2000# - ok. Perforate from 2907-3267' w/22 holes w/3-1/8" select fire gun loaded with 19 gram charges 1 SPF (.46" hole size). Acidize perfs w/2500 gals 15% HCL acid dropping 44, 7/8" ball sealers. Swab well.

Frac well with 100,369# 12/20 sand and 32,000 gals of Lightning 2500. TIH and tagged fill at 3073'. Clean out fill from 3073-3300'. Drill out fill and BP at 3320'. TIH and tagged fill at 3652'. Clean out to PBTD 3760'. TIH w/113 jts 2-3/8" tbg set at 3675'. TIH w/pump and rods. Put well back on production.
