12/31/06 Cemented second stage with lead of 1175 sx Interfill H SBM + 0.125# Poly-E-Flake (wt 11.9, yld 2.45) and tail of 150 sx Premium (wt 15.6, yld 1.18). Circulated 110 sx to surface on second stage. Released rig.

01/08/07 Pressure tested 5-1/2" casing to 3000# psi for 30 minutes. Ran CBL and found TOC @ surface.
