

The Monsanto State #6 is on the NMOCD Inactive Well List. It was already shut-in when Pogo purchased the lease and took over operations in August 2005. NMOCD records indicate the well has not produced since October 1995.

Pogo is anticipating conducting a tertiary (CO2) recovery program in the Paduca Field in which the Monsanto State #6 would be a part of and if successful, would hopefully be able to return the well to producing oil and gas in commercial quantities. Given the scarcity of CO2 at this time, our plans have been delayed until such time as an adequate supply of CO2 is secured.

Accordingly, Pogo request that the NMOCD allow this well to be TA'd with the understanding that it will be returned to production once the project is completed and CO2 is being injected. An MIT will be conducted and witnessed yearly until such time the well is returned to production. If the well fails the MIT and is considered too costly to repair, a Sundry Notice asking permission to P&A the well will be filed at that time.
