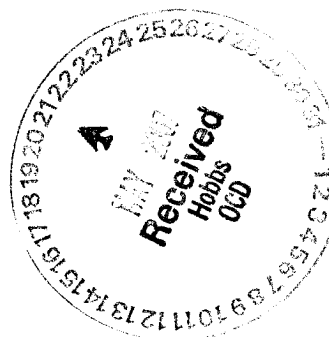

Spud well @ 1:30 PM MST, 05/02/07 (notified OCD of plan to spud)

5/4/07 Ran 28 jts. 8-5/8", 24#/ft, J-55 surface casing and set @ 1218'. Cemented w/ 400
