Spud well at 0100 hrs 3/5/2007 w/9-7/8" bit. Drill to 1255'. Set casing at 1228'. Cmt 7", 20# J55 ST&C csg w/400 sx Class "C" (35:65:6) + 5% salt + 1/4# celloflake. Tail w/200 sx Class C + 2% CACL2. Circ. 80 sx. Drilled to TD 3800'. Run logs. Set 4.5", 11.6# J55 LT&C csg @ 3797' w/175 sx BJ lite 50:50:POZ C + 10% gel + 5% salt. Tail w/200 sx Class "C" + .6% FL-62 + 2% SMS. Circ. 44 sx.

Run logs. Perf well from 2855-3702' w/52 holes, 1 SPF. Acidize perfs w/3526 gals 15% HCL acid w/104 ball sealers. Swabbed well 3 perfs w/298,931# 12/20 sand with Lightning 2500 gel. Clean out well to 3705' PBTD. RIH w/109 jts 2-3/8" tbg. End of tbg at 3478'. RIH w/rods and pump. Place well on production.
